Summary:

. Section 242 of Title 18 makes it a crime for a person acting under color of any law to willfully deprive a person of a right or privilege protected by the Constitution or laws of the United States

For the purpose of Section 242, acts under "color of Law" include acts not only done by federal, state, or local officials within their lawful authority, but also acts done beyond the bounds of that official's lawful authority, if the acts are done white the official is purporting to or prelending to act in the performance of hisher official duries. Pleasons acting under color of I aw within the meaning of this statute include police offices, prisons guards and other law enforcement officials, as well as judges, care provides in public health facilities, and others who are acting as public officials it is not necessary that the crime be visited shed by a facilities, and others who are acting as public officials it is not necessary that the crime be used to she do the shed of the state of

The offense is punishable by a range of imprisonment up to a life term, or the death penalty, depending upon the circumstances of the crime, and the resulting injury, if any.

TITLE 18, U.S.C., SECTION 242

Whoever, under color of any lew. statute, ordinance, regulation, or custom, willfully subjects any person in any State. Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States... shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatment use of a dangerous weapon, explosives, or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse.



The Haupt Case

The Supreme Court sustained a conviction of treason, for the first time in its history, in 1947 in Haupt v. United States. 10 Here it was held that although the overt acts relied upon to support the charge of treason — defendant's harboring and sheltering in his home his son who was an enemy spy and saboteur, assisting him in purchasing an automobile, and in obtaining employment in a defense plant—were all acts which a father would naturally performfor a son, this fact did not necessarily relieve them of the treasonable purpose of giving aid and comfort to the enemy. Speaking for the Court, Justice Jackson said: No matter whether young Haupt's mission was benign or traitorous, known or unknown to the defendant, these acts were aid and comfort to him. In the light of this mission and his instructions, they were more than casually useful; they were aids in steps essential to his design for treason. If proof be added that the defendant knew of his son's instruction, preparation and plans, the purpose to aid and comfort the enemy becomes clear. 11

Summary:

Section 242 of Title 18 makes it a crime for a person acting under color of any law to willfully deprive a person of a right or privilege protected by the Constitution or laws of the United States.

For the purpose of Section 242, acts under "color of law" include acts not only done by federal, state, or local officials within their lawful authority, but also acts done beyond the bounds of that official's lawful authority, if the acts are done while the official is purporting to or pretending to act in the performance of his/her official duties. Persons acting under color of law within the meaning of this statute include police officers, prisons guards and other law enforcement officials, as well as judges, care providers in public health facilities, and others who are acting as public officials. It is not necessary that the crime be motivated by animus toward the race, color, religion, sex, handicap, familial status or national origin of the victim.

The offense is punishable by a range of imprisonment up to a life term, or the death penalty, depending upon the circumstances of the crime, and the resulting injury, if any.

TITLE 18, U.S.C., SECTION 242

Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, ... shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse, or an attempt to kill, shall be fined under this title, or imprisoned for any term of years or for life, or both, or may be sentenced to death.

Mpatapo

Mpatapo is a symbol image from the Adinkra (a system of symbols from Ghana in West Africa). It is meant to represent the "knot of pacification/reconciliation," and as such it is the symbol for reconciliation, peacemaking and pacification. "Mpatapo represents the bond or knot that binds the separate parties in a dispute to a peaceful, harmonious reconciliation. It is a symbol of peacemaking after strife." The Historical Age of Adinkra Dates Back more than two full centuries and it's origin is African Wisdom Symbolism Communications [non-literacy meanings] which are basic root communication structures that even breaks or overrides both written and spoken language barriers between peoples. Mpatapo is very important and is one of very few symbols in the Adinkra set of over 100 considered a Solomon's Knot symbol of importance.



I. PURPOSE:

The purpose of this policy is to establish a process for Covered Staff, as defined below, to report compliance and other regulatory issues, including issues related to Prospect's Code of Conduct, policies and procedures, and applicable laws and regulations, so that they can be appropriately reviewed and addressed.

II. SCOPE:

This policy applies to all Prospect employees, regardless of employment status (full-time, part-time, per diem), and physicians or other medical staff with contractual arrangements and/or administrative positions with Prospect ("Covered Staff).

III. DEFINITIONS:

- 1. "Compliance Hotline" is the Compliance Ethics and Action Hotline, which is available 24 hours a day, seven days a week, by telephone or via the website at 1-844-PMETHIC (1-844-763-8442) or https://prospect.ethicspoint.com.
- 2. "Compliance Issue" is an actual or potential issue that relates to any of the following:
- a. Prospect's Code of Conduct;
- b. Patient privacy
- c. Coding, documentation, billing or reimbursement
- d. Accreditation and/or Practitioner credentialing
- e. Patients' rights;
- f. Financial incentives from or to a patient or a referral source (Stark Laws and/or Anti-Kickback Statute)
- g. Conflict of interest
- h. Medical necessity
- i. Quality of care and/or regulatory standards
- 3. "Prospect" is defined as Prospect Medical Holdings, including its hospitals, clinics, and its wholly-owned subsidiaries and affiliated entities.
- 4. "Prospect Finance Policies" means Prospect's policies and procedures relating to its financial and accounting practices and standards.

IV. POLICY:

Prospect expects its Covered Staff to report Compliance Issues or other regulatory issues as described by this policy as soon as possible after becoming aware of the issue or concern.

- 1. General Duty to Report: Covered Staff who become aware of a Compliance Issue, other regulatory issue or a possible violation of Prospect policies and procedures, including Prospect Finance Policies, should promptly inform their supervisor. Covered Staff also can report issues or concerns to a director, vice-president, Facility or Entity Compliance Officer(CO), Chief Compliance and Privacy Officer, or through the Compliance Hotline.
- To Whom to Report: A supervisor, director or vice-president who receives a report of a Compliance Issue, should promptly escalate the concern to the Facility/Entity Compliance Officer or Chief Compliance and Privacy Officer or Chief Human Resources Officer, as appropriate.
- 3. Reporting Government Auditsdnvestigations: Notices of government audits and investigations should be reported immediately to Prospect's General Counsel with a copy to the facility Compliance Officer and/or Chief Compliance and Privacy Officer.
- 4. Reportlnz Serious Adverse Events, Risk Incidents and Surveys: Serious adverse events should be reported to the facility/entity quality or risk officer and the Regional Vice President of Quality and Patient Safety immediately in accordance with the SSE Policy. Risk incidents or events, including professional conduct, workplace violence, verbal or physical threats or actions, security issues and reportable events, should be reported in the Catalyst system, or comparable system until such time as Catalyst is fully implemented. The facility/entity quality or risk officer and the Regional Vice President of Quality and Patient Safety also should be informed immediately when government surveyors are in the facility or notify the facility/entity of an upcoming survey or inspection.
- 5. Mandated Reporter Obligations: Mandated reporters also have an obligation to report known or suspected abuse or neglect as defined under state law to the appropriate state authority. You may consult with the local compliance officer or the Chief Compliance and Privacy Officer if you have questions about these obligations.
- 6. Reportine Harassment, Discrimination and Retaliation: Issues or concerns involving harassment, discrimination or retaliation, including sexual harassment, or possible violation of a Prospect human resource policy, should be reported to the facility human resources officer.

- 7. No Retaliation: It is not permitted to retaliate against Covered Staff who raise Compliance Issues and/or other concerns in good faith regarding possible illegal activities in the workplace. Any Covered Staff who engages in retaliation will be disciplined in accordance with Prospect policies and procedures and the Employee Handbook.
- 8. Enforcement: Covered Staff who do not comply with this policy may be subject to appropriate performance management pursuant to all applicable policies and procedures, up to and including termination. Such performance management may also include modification of compensation, including any merit or discretionary compensation awards, as allowed by applicable law.

V. PROCEDURE:

- 1. Covered Staff are expected to cooperate with those departments responsible for reviewing and investigating Compliance Issues and other regulatory matters, including the offices for Compliance, Risk, Quality, Human Resources and legal counsel. Covered Staff cooperation means responding promptly, completely and accurately to requests related to reviews and investigations.
- 2. Covered Staff also may report matters via the Compliance Hotline. While it is preferable for individuals to identify themselves so the information can be investigated thoroughly and promptly, issues also may be reported anonymously. Reports to the Compliance Hotline

are kept confidential, to the extent possible. Calls are not recorded, nor can they be traced back to the caller.

- 3. Potential compliance and ethical issues reported to the Compliance Hotline will be reviewed to identify the compliance-related matters and to determine the authenticity and credibility of the information provided by the person(s) making the report.
- 4. Upon receipt of a report of a Compliance Issue or other regulatory issue, the relevant office will review and address in accordance with their respective procedures and will coordinate with other offices, consultants and/or counsel with expertise regarding the relevant topic, as appropriate.

The first response from Brian was that I was unclear, to explain the problem better. I did so, again, in short texts. He said that I seemed preoccupied and perhaps I should text later. At that point I was so hurt by his dismissal and my own horrible state that I couldn't tell him that he had made everything worse by dismissing me. I complained to the crisisting latent but I got no reply beyond a bot.
